### Atlantic Lithium Ltd - ESG Policy

#### 1. Purpose

Atlantic Lithium Limited ACN 127 215 132 (**Atlantic** or the **Company**) is a lithium development and exploration company with all of its key assets in West Africa. Atlantic is committed to managing its impact on the environment and its resources, as well as developing and maintaining strong relationships with the communities in which it operates. Atlantic recognises that all of the Company's stakeholders, inclusive of its employees, local communities and others, have a right to expect the Company commit to delivering on its environmental, social and governance (**ESG**) responsibilities.

#### 2. Environmental Responsibilities
